### Why they launched a program

Chamber Bucks was a successful paper based program for SCCDP generating significant sales each year. SCCDP were keen to introduce a new Gift Card to eliminate some of the issues of the paper program, such as the inability to offer change, and provide an improved experience for customers and Chamber businesses.

#### **Benefits**

Chamber businesses appreciate the easier transaction offered by the new Gift Card, removing the need for them to make paper check deposits. The technology through the card tracks spend, so businesses can see exactly how many dollars are coming into their business through the Gift Card. Gift Card sales is seen as a big benefit of Chamber membership, alongside the promotional aspect.

#### Challenges

A key challenge for SCCDP was establishing ongoing funding for the Gift Card program. They approached this by developing opportunities to sponsor the Gift Card through tiered Chamber membership levels. Members in the top level are able to have their logo featured on the Gift Card sleeve and on the Gift Card website, adding an avenue of visibility for the business in Seward County and demonstrating their commitment to the community.

# **Opportunities**

By making Chamber membership a requirement to accept the card, SCCDP were able to drive membership and utilize the Gift Card as a key membership benefit. When businesses join the Chamber and the Gift Card, SCCDP takes a photo and promotes the business on their social channels. The Gift Card program also enables the Chamber to save staff time. 400 cards for a corporate order that would have taken days to process now takes only a couple of hours. This saves the Chamber significantly on staff administrative hours spent working on the program.
